The following information must be included:

- Employer name;
- Membership number of member (if known);
- Full name of member;
- Amount contributed for the member;
- Period for which the contribution is made;
- Date money was deposited (if paid by EFT); and
- Split-up of contribution paid (ie. employer contribution, salary sacrifice contribution, after-tax contribution).
